1 The Court, having reviewed the Seventh Interim Fee Application of
2 Receiver's Counsel, Allen Matkins Leck Gamble Mallory & Natsis LLP, for
3 Payment of Fees and Reimbursement of Expenses [August 1, 2018, through
4 October 31, 2018] ("Application"), including any supporting declarations and
5 objections filed therein, and being so advised in the matter and finding good cause,
6 orders as follows:

7 **IT IS ORDERED** that the Application of Allen Matkins is granted.

8 **IT IS FURTHER ORDERED** that Allen Matkins' fees and costs for the
9 Seventh Application Period are allowed and approved, on an interim basis, in the
10 amounts of \$109,133.10 and \$8,043.97, respectively.

11 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
12 pay Allen Matkins \$87,306.48 in fees and \$8,043.97 in fees from assets of the
13 receivership estate, which amount reflects an interim payment of 80% of the
14 allowed fees and 100% of the allowed costs.
